1. GRANTEE: UCLA Film and Television Archive  
Hollywood, CA
2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the one-way, one-time transportation in commerce of cellulose nitrate motion picture film from two locations in Hollywood, CA to climate-controlled film vaults in Santa Clarita, CA in alternative packaging. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
  - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
  - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.183 in that a non-DOT specification package is authorized; and § 172.302(c) in that marking the special permit number on the package is waived.
5. BASIS: This special permit is based on the application of UCLA Film and Television Archive dated June 27, 2007, and additional information dated September 4, 2007 submitted in accordance with § 107.105 and the public proceeding thereon.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Film must be packaged in a metal film can. The cover of the can must be securely held in place (snug friction fit, adhesive tape, or equivalent). A can may contain: 2000 feet of film (15" diameter can; gross weight is approximately 10 lbs.); 1000 feet of film (11" diameter can; gross weight is approximately 5 lbs.); or 400 feet of film (7" diameter can; gross weight is approximately 2 lbs.). The height of each can is 1 inch. Cans must be placed (stacked) on the shelves of a 24" deep x 36" wide three-shelf metal cart with a capacity of not less than 2000 lbs. The cart has framed mesh sides and back which extend 48 inches high from the bottom shelf to form a three-sided cart. The clearance between shelves is 15 inches. Each stack must contain not more than 15 cans. Each shelf must contain not more than 30 - 15" diameter cans; 60 - 11" diameter cans; or 120 - 7" diameter cans. Stacked cans on each shelf must be secured in the cart with shrink wrap.

b. OPERATIONAL CONTROLS -

(1) Film in cans on carts must be transported in a refrigerated box truck to provide temperature/climate control. The truck is equipped with a motorized lift gate. Carts must be secured in the truck to prevent movement.

(2) The one-time, one-way shipment is from Hollywood, Ca to Santa Clarita, CA, a distance of approximately 27 miles.

8. SPECIAL PROVISIONS:

a. A current copy of this special permit must be maintained at each facility where the package is offered for transportation.

b. The marking requirements contained in § 172.302(c) are waived.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

- o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term

"exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
